Therefore, the overall aim of the Workshop is to provide auditors and managers with a theoretical framework and a set of practical guidelines to:

- cut down the amount of time auditors have to spend on reports
- reduce the amount of time planning, organising, drafting and discussing reports and
- reduce the amount of time in interviews and meetings

**Yet still produce reports that are well received by all levels of readers!!**

### **Objectives:**

- Learn how to save time and money by structuring information in audit and risk assessment reports in a more "linguistically scientific" way
- Learn how to design and structure information so that your reports are clear and logical, and easy for the reader to understand after reading them for **the first time**
- Learn how to Plan, Organise, Draft, Revise, and Edit your own reports by following this Five Step Writing Process
- And as a result, develop a set of communication skills that will help you to write more effective reports that get results and action, and get the immediate approval of your boss
